SPECIAL RULES

1. Entered items must be accompanied by the recipe on a 5" x 8" card and must be typed. The recipe must be complete showing all ingredients used and the method of preparation. Please include Division and Class number with the name of the item. Name and complete address of exhibitor must appear on the reverse side of the card. These recipes will become the property of the Florida State Fair with right to use them at a future date. Do not send recipe with entry form.
2. Exhibitor cannot use any previous year's recipe.
3. No mixes may be used.
4. All entered items must be submitted in sealed, disposable containers or placed in a sealed plastic bag or the entered item(s) will be disqualified. Exhibitor name must appear on the bottom of the container.
5. No prepackaged foods may be used as the main ingredient (i.e. Jell-O, Cool Whip, etc.)
6. No pre-made piecrust or piecrust mix.

ACCEPTING ENTERED ITEMS

1. Adult & Youth Division entered items delivered by hand will be accepted at the Florida Center from 9:00 a.m. until 11:00 a.m. Saturday, February 18, 2012. Judging will begin following the delivery deadline.
2. **Award ceremony will commence at 5:00 p.m. on Saturday, February 18, 2012.**
