Entries must be picked up on Tuesday, February 21, 2012, and Wednesday February 22, 2012, 11:00 AM - 6:00 PM.

SPECIAL RULES

1. There is no upper or lower limit on the size of the entered item. Due to space limitations, the Fair may limit entered items to be assigned space on a first-come, first-served basis.
2. Dimensions must be included on the registration form or the entered item will be disqualified.
3. No more than six (6) items per person may be submitted for judging, and only one (1) entry per class.

- Decorative painting is a diverse art form utilizing a variety of techniques and media to decorate functional and non-functional surfaces.
- **Tole Painting** is the general term historically used to describe decorative painting on tin surfaces, especially in New England and by the Pennsylvania Germans.
- **Contemporary Decorative Painting** encompasses not only the folk art styles of Sweden, Norway, Germany, Russia, England, and Mexico, but many facets of Early American decorative painting such as stenciling, faux finishing, bronzing, gold-leafing, country painting, theorem and graining.
- **Professional Division** is for those who are professionally involved in the sale and/or instruction of decorative art.
