## **SPECIAL RULES**

1. The show is designed for the works of non-professional artists in the State of Florida. The non-professional artist is one who does not receive the major portion of his or her income from the sale of his or her art.
2. Each work of art will be screened for the following before acceptance:
  - A. Work must be of the artist exhibiting, no teacher assisted work.
  - B. Work must never have been exhibited in this Fair before.
  - C. Artists are to exhibit work completed during the past two years.
  - D. Paintings, prints and drawings must be framed, wired with screw eyes and ready to hang. No clips will be accepted.
  - E. All Art must be original, no copies, except Class 15.
3. In keeping with the Florida State Fair's family orientation; items of an offensive, controversial or objectionable subject matter will not be accepted.
4. No more than six (6) items per person may be submitted for judging, and only one (1) entry per class.
