1. Kit

The model has been built from components of a single commercial kit substantially as the manufacturer of the kit intended. Color schemes and/or markings may be changed; minor structural changes and nominal addition of non-kit components may be made to correct and/or improve detailing.

2. Kit Conversion

The model must demonstrate the use of components of commercial kits combined with hand-built parts and/or significant structural changes to kit components.

3. Built From Scratch

Models may represent the builder’s impression of any subject and need not necessarily be of a real object.
